On 9 April 2020, the Company announced the granting of an aggregate of 26,008,000 share options, in which 16,000,000 Share Options were granted to the executive Directors of the Company, at an exercise price of HK\$0.125 per share of the Company to the eligible persons under the Share Option Scheme. The market price of the Company's shares at the date of grant was HK\$0.125 per share. All of the share options are exercisable from the date of acceptance by a grantee to 8 April 2030 (both days inclusive). Each of the grantees had paid HK\$1 to the Company on acceptance of the offer of share option. No share options have been lapsed, however, 4,000,000 share options have been exercised and 2,504,000 share options have been forfeited up to date of this form.
